Art Show & Sale

Each month the Guild offers the Tri County Area artists a place to show and sell their artwork. It is an online art show and sale, open to both Guild members and artists who are not members of the Guild.

Each month up to 15 pieces of art submitted by artists will be shown in an online gallery hosted on our Square.com shop where the artwork can be seen and purchased.

Entries for the next month must be received by the fourth Friday of the month. The first 15 entries received will be used. The remaining entries will be put first in line for the following month.

The Online Gallery is held every month except those months in which the Guild has a physical exhibition or show.

ARTWORK SUBMISSION REQUIREMENTS:

Maximum of Entries:

Only one image may be submitted each month. It may be either For Sale or Not For Sale (NFS).

Two-Dimensional Work:

All work submitted in an eMail must be either a .jpg or a .png image file not exceeding 1 MB ins size. If submitted by mail, the photo must be at least 4" x 6" and not larger than 8" x 10". Photos will not be returned.

Three Dimensional Work:

All work submitted in an eMail must be either a .jpg or a .png image file not exceeding 1 MB ins size. If submitted by mail, the photo must be at least 4" x 6" and not larger than 8" x 10". Photos will not be returned.

General requirements:

- Only original artwork will be accepted and must not have been previously shown on Art by Internet. Copies or reproductions will NOT be accepted, nor will art that is derived from another artist's work, published/printed sources or photographs not originated by the submitting artists.
- The show committee reserves the right to reject artwork not meeting all the above requirements or any work they deem unacceptable for this exhibit.
- All artwork must be for sale or marked NFS (not for sale). No POR (price on request) will be allowed. A 10% commission will be retained on the sale of all work. Artists will receive a check for the balance shortly after the close of the sale. Artists will be notified by e-mail or phone if an entry sells.
- For all sales, the Guild will collect the 6% Pennsylvania Sales Tax and remit to the Pennsylvania Department of Revenue.
- The artist will be responsible for contacting the buyer and arranging for delivery of the artwork. If the artist cannot negotiate acceptable delivery arrangements within 30 days of receiving notice of the sale, the artist must inform the Guild to have the purchase refunded.

ENTRY FEES:

Entry fees are non-refundable

PAAG Members: Free.

Non-Members: \$10 Entry fee for each entry.

Non-members may join the PAAG for \$35 at time of entry, and then pay the member entry fees. Our membership year is from September 1st through August 30th.

Entry fees and membership dues must be received by the 4th Friday of the month preceding the exhibit in order for the artwork to be included in the monthly exhibit.

ENTRY INSTRUCTIONS:

Entries including the entry form and image file or photograph must be received by the 4th Friday of the month preceding the exhibit.

Only the first 15 entries received will be shown in the month. If more than 15 are received, the remainder will be put first in line for the following month.
